



RESOLUTION NO. 61-11

A RESOLUTION OF THE BOARD OF SUPERVISORS OF NAVAJO COUNTY, ARIZONA, ADOPTING A NEW VOTING PRECINCT MAP AND POLLING PLACES PURSUANT TO A.R.S. § 16-411

WHEREAS, A.R.S. § 16-411 requires the Board of Supervisors to meet each December of the year preceding the year of a general election for the purpose of establishing a convenient number of election precincts in the county and defining the boundaries of those precincts; and

WHEREAS, pursuant to A.R.S. § 11-212 and A.R.S. § 15-1441(A), the Board on November 15, 2011 adopted new Supervisorial District boundaries and Northland Pioneer Community College Precincts; and

WHEREAS, newly proposed Congressional and Legislative Districts boundaries have been released which Navajo County expects to ultimately be adopted; and

WHEREAS, the County has a need and desire to make improvements to and simplify its existing election precinct maps and boundaries; and

WHEREAS, County staff have made recommendations to the Board regarding new precinct lines that would (1) be consistent with the new redistricting plans adopted by the County and being considered on the State level, (2) eliminate voter confusion in some areas of the Navajo Indian Reservation by using precinct boundary lines that follow Chapter boundary lines used in elections held by the Navajo Nation, (3) enhance the efficient use of County election resources, (4) eliminate unnecessary and unneeded voting precincts, and (5) accomplish all of the foregoing without any significant inconvenience to any group of voters in the County;

NOW, THEREFORE, BE IT RESOLVED by the Board as follows:


- 1.) That a new precinct map and updated boundaries attached hereto and incorporated herein as "Exhibit A." are hereby approved by the Navajo County Board of Supervisors.
- 2.) The polling places to be utilized for each of these precincts pursuant to A.R.S. §16-411(B) are fully set forth in "Exhibit B." Each of these polling places has previously been utilized by the County in past elections.
- 3.) That the board finds that as to the precincts set forth in "Exhibit C," there is no suitable polling place within the precinct that the County can utilize for election

purposes. As to these precincts, the Board has established the polling place in an adjacent precinct pursuant to A.R.S. §16-411(B)(2).


- 4.) That the County Attorney's Office is hereby authorized and directed to submit the new voting precinct map attached hereto to the United States Department of Justice for preclearance.


