NAVAJO COUNTY REDISTRICTING PROJECT**

Navajo County hereby informs the public that a member of the Navajo County Redistricting Advisory Committee, **Robert Black Jr.**, will hold a meeting open to the public on **Monday September 12**, for the purpose of seeking public input and comments regarding the County's redistricting of the Supervisorial Districts and Northland Pioneer Community College District precincts. The meeting will be held in **Pinon, Arizona at the Pinon Chapter House at 5:30 p.m. DST**

The Navajo County Board of Supervisors is required to redistrict every ten years after the release of the decennial census. For this reason, the Board of Supervisors has established a Redistricting Advisory Committee to seek out public input regarding where the new district lines should be drawn, and ultimately to make recommendations to the Board of Supervisors about a redistricting plan for the County. The input of the public is welcomed and strongly encouraged in these efforts.
