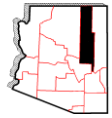

**NOTICE OF INTENT TO DISCHARGE UNDER A GENERAL AQUIFER
PROTECTION PERMIT FOR AN ON-SITE WASTEWATER TREATMENT FACILITY**
****GP 4.02 Conventional Septic Tank System****

Instructions: Please fill out and submit this Notice of Intent to Discharge (NOI) to obtain permission to construct and discharge from a new on-site wastewater treatment facility for a **conventional septic tank system**. Any required **NOI Supplemental Forms** needs to be completed and submitted.

1. **Constructing and Operating an On-site Wastewater Treatment Facility Under a GP 4.02 General Aquifer Protection Permit:** Arizona Administrative Code (AAC) R18-9-A301 prescribes the following process for a person to obtain permission to construct and operate an on-site wastewater treatment facility:
 - a. Submit this NOI and appropriate supplemental information and forms;
 - b. Remit applicable general permit fees (due upon issuance of permit);
 - c. Satisfy any deficiency requests arising from Navajo County the agency's pre-construction review of the submitted information;
 - d. Receive **NCERA Form 380 Provisional Verification of General Permit Conformance** authorizing construction;
 - e. Complete construction of the wastewater facility within two years;
 - f. Upon completion of construction, submit required information to Navajo County to initiate post-construction review and inspection;
 - g. Satisfy any deficiency request arising from the agency's post-construction review of the facility;
 - h. Receive **NCERA Form 390 Verification of General Permit Conformance** authorizing operation and discharge from the facility in accordance with terms of the general permit and applicable requirements of statute and rule;
